Dear Trader,

Enclosed, please find a Trader Application and a flyer for the **53rd** O-SA-WAN powwow August 22-23, 2009 at the Boone County Fairgrounds in Belvidere, IL. If you are interested, please complete and return the Trader Application and appropriate Trader/Electric Fees to me at the address listed below.

**Changes this year imposed by the Boone County Fairgrounds:** The fairgrounds will be charging an additional **\$25.00 per day** for any camper, motor home, tent or device (such as a coffee pot) that connects to the electrical system. If you plan to camp either with your booth or away from your booth and will require an electrical hookup of any kind, please include an additional \$25.00 per day with your trader fees.

The cost per Trader space is \$140.00 until August 1st and \$165.00 after August 1st. \$35.00 from each trader space fee will be used to purchase advertisement in area newspapers.

Each space is approximately 20 feet across the front with electricity close by. You will need to furnish your own canopy, tables, chairs, lights, extension cords, and adapter to tap into the lights. The depth of the spaces varies from 20 feet to about 40 feet so you could camp behind or near your set-up. **There is no walkway between spaces unless you provide one from part of your space.**

I will assign Trader spaces as I receive completed Trader Applications and Trader Fees as follows:

- If you were a Trader at last years O-SA-WAN powwow and if I receive your Trader Application and Trader fees by July 1<sup>st</sup> 2007, I will assign you the same space you had last year.
- If you were a Trader at last years O-SA-WAN powwow and if I receive your Trader Application and Trader fees after July 1<sup>st</sup>, I will assign spaces on a first come basis from the remaining spaces as payment is received.
- If you were not a Trader at last years O-SA-WAN powwow spaces are assigned on a first come basis as Trader Application and Trader fees are received after the July first deadline. Open spaces on the circle are limited, the sooner I receive applications and fees, the better your chance of getting a space on the circle.
- I will be sending you a confirmation letter listing your space assignment and a site map.

If you will be serving food, please remember that you must get a permit from the Boone County Department of Public Health - 1204 Logan Avenue - Belvidere, IL 61008 - (815) 544-2951. You must get this before the powwow. There will be a County Health Inspector on the powwow grounds. Also, the electrical fee for food booths is \$35.00 per day rather than the \$25.00 per day for a non food booth.

Trader Setup starts at the Fairgrounds at Noon on Friday August 15th until 10pm and resumes at 7am on Saturday August 16th until 11am. **You will not be allowed onto the fairgrounds until Noon on August 21st - NO EXCEPTIONS! There are no events scheduled for August 21st.**
